The Tournament Director of the year is a current, active TD, usually an ANTD/NTD but can be a Senior TD. They have functioned at a high level, and haven't had any complaints sent to TDCC about them or the complaints were frivolous and unwarranted. They are generally seen by their peers to be an excellent TD and players usually feel the same way.

The Tournament Director - Lifetime Achievement is a TD who has had very distinguished career as a director and has contributed to the field of Tournament Directing. They will be typically be directing less tournaments now having slowed down or are retired. They have influenced other TDs in their career and have probably served as mentors to many beginning directors.

The TD Lifetime Achievement award should not be seen as a duplication of the TD of the Year award. Someone can win Lifetime Achievement ten years after having won TD of the Year.

To avoid the appearance of conflict of interest or being seen as self-serving, while also recognizing that many excellent TDs are also on the committee, the TDCC each year can recommend one of their own for One of the two awards, but not both.

The affiliate is informed that it has systematically violated the player's right to an on-site TD and all such tournaments run with no on-site TD show extremely questionable judgment on the part of the officers of the affiliate

The affiliate is warned that if it runs any further events with no on-site TD then it risks immediate suspension or revocation.

EB14-019– **Unruh** - Moved, that the USCF shall replace the Three Month Promotional Trial Membership with a membership fee of \$10.00 per event without printed magazine. Furthermore, the membership is only offered through the TD/A. The Tournament Membership is not available for any National events. The effective date for the amended membership change is January 1st, 2014. **PASSED 7-0**

National Chess Day 2014 will be Saturday, October 11th. In order to promote National Chess Day as a day for special activities and promotion of chess throughout the country, the following is proposed:

- a. Any Rated Beginner Open that includes "National Chess Day" in its TLA title gets both a free TLA and free rating fees.
- b. Any 1-day event for Oct 11 which has "National Chess Day" in its TLA title gets a free TLA
- c. Any 2-3 day event held over a period which encompasses Oct 11-12, which has "National Chess Day" in its TLA title, will get a free TLA and free rating fees
- d. For organizers/affiliates, In the TLA, be sure to mention National Chess Day in the title and that it actually happens on Saturday Oct 11, and then expect to receive an e-mail from the office explaining how to get the free rating fee.
- e. Organizers are encouraged to submit articles and photographs for publication for Chess Life Magazine and Chess Life Online. Affiliates are encouraged to plan a tournament or an event of any kind in order to promote chess on National Chess Day. The USCF will send out at least one e-mail blast to all TDs and Affiliates before April 1 to enable organizers to have multiple weeks to plan events before the June 10 TLA deadline for getting Chess Life TLA's in August and September. PASSED 7-0.

EB14-031 – **Board** - The Executive Board upholds the decision of the Ethics Committee in the Xue (Li) vs Harper case. **PASSED 7-0.**
