The following five motions arose from closed session and were voted in open session later the same day:

EB19-005 – **Board** The Executive Board moves that the US Chess Federation endorses the candidacy of GM Nigel Short and his ticket for the Presidency of FIDE. **PASSED 7-0**

Allen Priest moved by e-mail on August 6, 2018, to add Anjelina Belakovskaia to the Women's Committee. It passed unanimously the same day.

EB19-006 – Priest I move that Anjelina Belakovskaia be added as a member of the Women's Committee. PASSED 7-0

Mike Nietman indicated that the Scholastic Council has completed the 2018-2019 Scholastic Regulations and focused on the need to have the regulations in place by no later than September 1 each year. He moved their approval by e-mail on August 8, 2018, by e-mail with the regulations attached. The vote was completed the next day. President Allen Priest noted that "I would like it to be noted in the minutes the appreciation of the EB to the scholastic committee/council and the EB liaison Mike Hoffpauir for their work in getting this done in time for the start of school and months earlier than the last few years."

EB19-007 - Nietman - I move that the 2018-19 Scholastic Regulations be approved. PASSED 7-0

Mike Hoffpauir moved by e-mailed objections procedure on August 10, 2018, to add Dr. Mike Regan to the Ratings Committee.

EB19-008 – **Hoffpauir** - Under our 5-day "by exception" procedure for adding new members to committees, I hereby move that Dr. Mike Regan (NJ) be added to the US Chess Ratings Committee per the request of Committee Chair, Dr. Mark Glickman." There is no need to respond to this request unless there is an objection. Allen will "call the vote" after 5 calendar days, e.g. next Wednesday, Aug 15th. **PASSED** without objection

Chuck Unruh moved on August 10, 2018, to add James R. Thoune to the Accessibility and Special Circumstances Committee (A&SCC) by e-mailed objections procedure. No objections were received by August 15.

EB19-009 – **Unruh** - I move that James R. Thoune 12423385 Life Member become a member of the A&SCC in 5 days if there are no objections. **PASSED** without objection

Chuck Unruh moved on August 14, 2018, to add Philip Linninger to the Accessibility and Special Circumstances Committee (A&SCC) by e-mailed objections procedure. No objections were received by August 19.

EB19-010 – **Unruh** - I move that Philip Linninger USCF# 14895972 become a member of the A&SCC by request of the Chairperson in 5 days if there are no objections. **PASSED** without objection.

Mike Nietman noted by e-mail on August 16, 2018, that he received a request for several changes to the Senior Committee from its Chair David Grimaud and moved their adoption by objections procedure. They will pass automatically if no objections are received by August 21.

Mike Hoffpauir moved on August 19, 2018, by e-mailed objections procedure the addition of Steve Immitt to the Competition Integrity Committee. If no objections are received by August 24 the motion would pass at that time. It did.

EB19-012 – Hoffpauir - Under our 5-Day without objections process, I move to add Steve Immitt (NY) to the Competition Integrity Committee (formerly known as the Anti-Cheating Committee). **PASSED** without objection.

Chuck Unruh offered a motion by e-mail objections procedure on August 26, 2018, to remove Philip Linninger and Will Barela from the Accessibility and Special Circumstances Committee (A&SCC) at the request of the committee chair and to make Judit Sztarary a Vice Chair of that committee. Three things were unusual about the motion that eventually resulted in further discussion and new motions.

The first issue was that it would reverse motion EB19-010 (See above), which only nine days earlier added Philip Linninger to the A&SCC. Discussion centered around whether to include both motions or simply remove the earlier motion. Both motions need to be documented.

The second issue was that it would name a Vice Chair by objections Procedure (which is currently not allowed). Ryan Velez offered a motion on September 3, 2018, to name Sean Manross Vice Chair of the Clubs Committee by objections procedure and resubmitted his motion by objections procedure on September 4 to name Judit Sztarary Vice Chair of the A&SCC. Please note that any changes in Chairs, Co-chairs or Vice Chairs will also affect the Committee Appendix.

During discussion Mike Nietman pointed out that Mike Atkins' Motion EB16-044, which is still in effect, is worded "Moved, that in between scheduled meetings of the EB, that appointments of regular committee members (non-chair or co/vice chair) will be presented by an EB member by e-mail who posts "Mr/Ms _____ will become a member of ____ committee in 5 days with no objections" Please note that the reason for this is that the objections procedure is to be used only where there is little chance for needed discussion or objections. The naming of Committee Chairs, Co-Chairs or Vice Chairs can sometimes require discussions that can be sensitive enough that they are usually named in closed session EB meetings. Objections procedure motions preclude such discussions. Allen Priest pointed out on the same day that "The EB appoints chairs of EB committees through regular voting procedures, not through objections procedures. The appointment of chairs is not up to committees, nor is it up to the liaison, which is what the objections procedures basically allows." He also clarified the current status, saying "There is no pending appointment of any chair or vice-chair for either Accessibility or Clubs." Ryan Velez withdrew his motion. Primary liaison Chuck Unruh moved replacement motions on September 6, 2018, and September 23, 2018 (See motions EB 19-017, 018).

The third issue was that it was actually two separate motions submitted as one and could have the unintended consequence of an objection to one affecting the other. The motion itself was not voted and ultimately withdrawn.

EB19-013 – **Unruh** - I move to remove Will Barela USCF# 12592643 and Philip Linninger USCF# 14895972 from service on the Accessibility and Special Circumstances Committee if there are no objections within the next 5 days. I move that Judit Sztarary USCF# 14708926 become the A&SCC Vice Chairperson if there are no objections within the next 5 days.

Ryan Velez moved by e-mail objections procedure on August 28, 2018, to remove Michael Lenox from the A&SCC at the request of the committee chair. He noted that this is part of a committee reorganization.

EB19-014 – **Velez** - I move to remove Michael Lenox ID# 12734131 from service on the Accessibility and Special Circumstances Committee if there are no objections within the next 5 days.

Allen Priest replied to an appeal of the Ethics Committee recommendations with the following detailed motion. The motion was made by e-mail on August 30, 2018. Voting was completed the next day, however it contained a factual error which resulted in an amendment to the wording. The amended motion was submitted by e-mail on August 31, 2018, and voting was completed on September 11, 2018. The final wording is presented here.

EB19-015 – **Priest** - I move to amend the motion regarding the appeal of Ethics Committee recommendations to correct a factual error as follows:

In the matter Weideman vs Young, Cusi, Cartegena, Silvestre, Castro and NorCal House of Chess, The US Chess Executive Board takes the following actions in response to various appeals: **PASSED 7-0**

Ronald Cusi: Mr. Cusi submitted a written appeal of the Ethics Committee recommendations. He was offered the opportunity to address the Executive Board by phone. He declined that opportunity by email response.

After considering the written appeal of Ronald Cusi, the Executive Board upholds the recommendation of the Ethics Committee. The US Chess membership of Ronald Cusi is suspended for three years. The tournament director certification of Mr. Cusi is permanently revoked.

Omar Cartegena: Mr. Cartegena submitted a written appeal of the Ethics Committee recommendations. He was offered the opportunity to address the Executive Board by phone. He declined that opportunity by email response.

After considering the written appeal of Omar Cartegena, the Executive Board upholds the recommendation of the Ethics Committee. The US Chess membership of Omar Cartegena is suspended for three years.

Ted Castro: Mr. Castro submitted a written appeal of the Ethics Committee recommendations. He was offered the opportunity to address the Executive Board by phone, which he chose to do.

After considering both the written appeal and the phone appeal of Ted Castro, the Executive Board upholds the recommendations of the Ethics Committee in part and amends in part.

The tournament director certification of Ted Castro is permanently revoked. The US Chess membership of Mr. Castro is suspended for three years.

The Executive Board upholds the Ethics Committee recommendation that the NorCal Team be stripped of their 2018 US Amateur Team West championship title.

Mr. Castro's appeal extended to the affiliate NorCal House of Chess. After considering both the written appeal and the phone appeal of Ted Castro on behalf of the affiliate NorCal House of Chess, the Executive Board rejects the Ethics Committee recommendation to permanently revoke the affiliate status of NorCal House of Chess. In recognition of the substantial educational activities of this affiliate, the Executive Board places the NorCal House of Chess on probation for a period of three years. Any violation of the Code of Ethics or of US Chess affiliate standards by the affiliate, any officer of the affiliate, or any tournament director at an event submitted by the affiliate will result in the permanent revocation of the NorCal House of Chess affiliate status. Further, as a condition of the probation, NorCal House of Chess must appoint a tournament director who is certified by US Chess at the Senior level or higher to oversee all tournament activity and tournament rating report submissions by the affiliate. NorCal House of Chess will notify US Chess of the appointment which will be confirmed by US Chess with that tournament director. Failure to maintain the appointment of such a tournament director in this oversight role will result in the immediate suspension of the affiliate status of NorCal House of Chess, until an appropriately credentialed tournament director accepts such appointment.

Note: Angelo Young did not appeal the Ethics Committee recommendation suspending his US Chess membership for three years. Guerrero Silvestre did not appeal the Ethics Committee recommendation suspending his US Chess membership for five years and assigning him a rating floor of 1800. Those recommendations take effect without action by the Executive Board.

Allen Priest moved on September 6, 2018, by e-mail to reappoint Ruth Haring as our FIDE Zonal President. This can be done since the US is the only country in our FIDE Zone.

EB19-016 - Priest - I move that US Chess reappoint Ruth Haring as our FIDE Zonal President. PASSED 7-0

Chuck Unruh moved by e-mail on September 6, 2018, to make Judit Sztarary Vice Chair of the A&SCC. The vote was completed on September 23, 2018.

EB19-017 – **Unruh** - I move that Judit Sztarary USCF# 14708926 become the A&SCC Vice Chairperson. **PASSED 7-0** Please note: This is documented in a revision to Appendix A.

Chuck Unruh moved by e-mail on September 23, 2018, to remove Will Barela and Philip Linninger from the A&SCC. Voting was completed the next day.

EB19-018 – **Unruh** - I move to remove Will Barela USCF# 12592643 and Philip Linninger USCF# 14895972 from service on the Accessibility and Special Circumstances Committee. **PASSED 7-0**

Chuck Unruh moved by e-mail the approval of an agreement regarding royalties for US Chess endorsement of a clock on October 08, 2018, The vote was completed the following day.

EB19-019 – Unruh - I move that the Executive Board approve the Clock Royalty Endorsement Agreement between House of Staunton, Inc. and US Chess. The final version of the agreement is now date marked as 10/8/2018. **PASSED 6-0** with Ryan Velez recusing himself due to a possible conflict of interest.

Thanks to Kathleen Collins, who is retiring, for all that she has done for US Chess and for being willing to continue until such time that a replacement could be trained in her responsibilities. We wish Kathleen Collins the best for the future. Executive Director Carol Meyer moved by e-mail on October 09, 2018, that the signatories on the bank account be updated to reflect the transition. The vote was completed the same day.

EB19-020 – **Meyer** - I move that the Executive Board authorize the removal of Kathleen Collins as signatory to US Chess bank accounts and that Christine Green be added as a signatory to same. **PASSED 7-0**

Mike Hoffpuir moved by e-mail on October 15, 2018, the replacement of the chair of the Military Committee. He noted that "the "Chair" of the Military Committee rotates each year. It does this in order to align with the Service hosting the coming year's US Armed Forces Open (USAFO). In October 2019 during Columbus-Day weekend, the USAFO will be hosted by the US Marine Corps, at Camp LeJeune, North Carolina. Accordingly, Ms. Sara Walsh has stepped up and provided her name as Chairperson for the next year. Sara has long been involved in Military Chess in her capacity working for the Morale Welfare and Recreation department at Camp LeJeune. She is an active tournament player in NC whose rating hovers around 1900. She also served ably as "House Man" during the 2018 NATO Chess Championships held at Texas Tech University. As a part of this process of rotating the Chair, the current Chairperson, US Navy Captain Thomas Belke, has submitted his resignation to be effective the date his successor is approved by the Executive Board." The vote was completed the next day.

EB19-021 – **Hoffpauir** - I move that the Executive Board (EB) accept the resignation of Captain Thomas Belke, US Navy (Retired) from his position as Chairperson of the US Chess Military Chess Committee, and that the EB approve the nomination of Ms. Sara Walsh (USCF 12457717, exp. 3/2019) as Chairperson. As Chairperson, Sara will serve as the Principal Organizer for the 2019 US Armed Forces Open Chess Championships being planned for October 2019 at Camp LeJeune, NC. **PASSED 7-0**

Allen Priest moved by e-mail on October 16, 2018, a five year extension of the affinity contract with Nationwide Insurance. Voting was completed on October 21.

EB19-022 – **Priest** - After the recommendation of Executive Director Carol Meyer, I move that US Chess authorize Carol Meyer to execute an extension of the Nationwide insurance affinity contract for five years. The contract terms and obligations remain largely unchanged; there are minor changes in language recommended by the US Chess corporate counsel which have been accepted by Nationwide. **PASSED 7-0**

Allen Priest moved by e-mail on October 19, 2018, the suspension of Steve Shutt from service on US Chess Committees until allegations against him are resolved. After a brief discussion period to perfect the wording the motion was worded as

shown below. Voting was completed on October 21, 2018.

EB19-023 – **Priest** - Due to recent published reports of serious accusations related to potential child abuse, in accordance with US Chess policy regarding committee service, I move to suspend Steve Shutt from service on the Chess in Education Committee, Denker Tournament Committee, Barber Tournament Committee, the Scholastic Committee, and the Scholastic Council. The suspension from committee service will remain in effect until the allegations can be resolved. **PASSED 7-0**

Mike Nietman moved the approval of the minutes of the August EB meetings on by e-mail on October 21, 2018. Voting was completed the same day

EB19-024 – **Nietman** - I move to accept the previously distributed minutes of the August 2, August 4 and August 5, 2018 Executive Board meetings. **PASSED 7-0**

The Development Committee, which had been inactive in the last two years, is now active thanks to John D. Rockefeller V, who volunteered to chair the committee in an informal discussion at the Madison meeting. The Executive Board did not make a motion at that time to name him as chair. He has since requested that two members be added to the committee. The next two motions document the committee's current status.

EB19-025 – **Priest** I move that John Rockefeller be appointed chair of the Development Committee. **PASSED 7-0** Please note that the primary EB liaison is Randy Bauer and the Alternate EB liaison is Mike Hoffpauir.

As liaison to the Development Committee and at the request of Committee Chair John D. Rockefeller, Mike Hoffpauir moved the addition of Sunil Weeramantry And Kimberly Doo McVay to the Development Committee by e-mailed five day objections procedure.

EB19-026 – **Hoffpauir** - Under our 5-day objections procedure I move that Sunil Weeramantry (USCF 11155189, exp. 7/2019) and Kimberly Doo McVay (USCF 16085728, exp. 8/2019) be added to the Development Committee per the request of Chairperson John Rockefeller. **PASSED** without objection.

The US Chess Executive Board met in New Orleans, LA, on November 10-11, 2018. The following motions arose from that meeting. Please note that motion EB19-027 originated as an e-mail motion. By November 10 the count was 6-0. The voting was completed at the meeting when the one member who had not yet voted cast his vote.

The College Chess Committee voted to name Kelly Bloomfield of Ohio State as its new chair, effective 12/01/18. Mike Nietman moved by e-mail on November 06, 2018, to name Kelly Bloomfield Chair of the College Chess Committee. He made the motion at the start of the meeting since the vote was 6-0 and only one vote remained to be counted. The motion passed 6-0 and the remaining vote was received by e-mail on November 12 to complete the 7-0 result.

EB19-027 – **Nietman** - I move to name Kelly Bloomfield chair of the College Chess Committee effective December 1, 2018 and to thank Al Lawrence for his service as chair. **PASSED 7-0**

Allen Priest made four motions on Saturday, November 10 which involved setting up an investment committee for the Reserve Fund and the Professional Players Health and Benefit Fund (PPHBF), transfer funds to the Reserve Fund/PPHBF, and specify an investment plan for it. VP of Finance Chuck Unruh was appointed Chair of the committee by President Allen Priest. Please note that this will be a separate standing committee to handle investments for both the Reserve Fund and the PPHBF. It does not replace the PPHBF Management Committee, which will continue as is.

EB19-028 – **Priest** - In accordance with the original motion (EB17-021) which set up the reserve fund, I move to transfer \$200,000 from the Regions Bank account to the Reserve Fund to increase that Fund to \$1.2 million.



Vouchers must be redeemed through the office in the same way that individual prison memberships are processed. The definitions applicable to the individual prison membership will all be applicable to this program. **PASSED 7-0**

EB19-040 – **Hoffpauir** - Under the 5-day objections procedure I move that we add Glenn Panner and Thad Rogers to the SAC and remove Stephen Plotnick, Robert Tanner and Jim Gray from the SAC. **PASSED** without objection

At the request of Rules Committee Chair Ken Ballou, Mike Hoffpauir moved the addition of Bill Smythe to the Rules Committee by e-mailed Objections Procedure. No objections were received and the motion passed automatically.

The Saint Louis Chess Club has offered to sponsor a new National Invitational for Seniors, starting with this year. Liaison to the Senior Chess Committee moved by e-mail to create the event on January 13, 2019. Voting was completed on January 17, 2019.

EB19-053 – **Unruh** – I move that the Executive Board create a new annual national event known as the U.S. Senior Championship with the 1st tournament held 2019 in Saint Louis at the Saint Louis Chess Club, 4657 Maryland Avenue, Saint Louis, MO 63108. - **Vision**: Chess is recognized as an essential tool that is inclusive, benefits education and rehabilitation, and promotes recreation and friendly competition. **PASSED 7-0**

EB19-058 – **Hoffpauir for Board** – I move to approve the following five (5) US Chess Goals developed by the Executive Board during the strategy workshop on January 11, 2019:

- Expand the social, recreational and rehabilitative applications of chess
- Develop the depth and breadth of our partnerships
- Use chess to increase opportunities for under-represented segments of society
- Continuously improve internal operations and member services PASSED 7-0

Secretary Mike Nietman moved by e-mail on February 12, 2019, the approval of the minutes of the January EB Meeting. The vote was completed two days later.

PLEASE NOTE: Chuck Unruh moved to adopt a revised set of guidelines for US Chess Invitational Requirements on February 18, 2019, which included the US Chess Senior Invitational. After discussion led to a need for additional consideration the sponsor withdrew the motion the next day. When a new motion is voted it will be numbered and documented.

EB19-059 - Nietman - I move to accept the minutes that were previously distributed for review and edited. PASSED 7-0

Executive Director Carol Meyer moved by e-mail on February 27, 2019, to approve a revision to the US Chess Transgender Policy to be consistent with the new US Chess mission statement after legal review. The essential difference is to add "A request to change gender must be done at least two weeks prior to participating in a US Chess rated event. US Chess policy is subservient to applicable laws." The vote was completed on March 5, 2019.

EB19-060 – Meyer – I move that the Executive Board approve the updated Transgender Policy that now reads:

The Executive Board moves to adopt the following transgender policy as provided by legal counsel: Allow a person to identify as they choose, and allow each person one change to their gender identification. If an individual attempts a second change to gender identification, at that time the individual must provide US Chess a birth certificate, and the birth gender indicated on the birth certificate will be used to determine gender for US Chess purposes. A request to change gender must be done at least two weeks prior to participating in a US Chess rated event. US Chess policy is subservient to applicable laws. PASSED 7-0

Rusty Harwood will be leaving the US and has resigned his seat on the US Chess Scholastic Council. He has been very valuable to US Chess and the cause of scholastic chess. We wish him all the best. His resignation leaves two open seats on the Scholastic Council. The Scholastic Committee elected Danny Rohde and Eric Vigil in a special election to fill those seats. Mike Nietman moved to accept Rusty Harwood's resignation with thanks and name the Scholastic Council's choices to terms that will expire in August, 2020. Voting was completed March 9, 2019.

EB19-061 – **Nietman** – I move to accept the resignation of Rusty Harwood from the Scholastic Council and name Danny Rhode and Eric Vigil to the Scholastic Council. The EB thanks Rusty for his service on the Scholastic Council. **PASSED 7-0**

EB19-064 – **Hoffpauir** - At the request of the Committee Chair, John Rockefeller, and under the terms of the Executive Board's 5-day no objections process, I move to add Danny Rohde to the US Chess Development Committee. **No Objections** were received.

The Fund may accept gifts subject to the general gift acceptance policy of US Chess. Donor restricted gifts may have restrictions that do allow for the invasion of principal of that gift for the stated purpose of the gift, but the intention is that the gift provides for benefits over multiple years. The Fund will be managed initially with the internal committee that is managing the US Chess Reserve Fund. Management of the Fund will have a longer-term focus than the Reserve Fund. The Fund will be established with a separate investment account at TD Ameritrade. **PASSED 7-0**

EB19-068 – **Priest** – I move that the US Chess Endowment Fund (the Fund) will be initially funded by the transfer of an amount equal to the benefactor portion of all benefactor membership paid to date. The estimate of this is 44 members at \$1,500 or \$66,000. The Executive Board directs that the benefactor portion of future benefactor memberships be added to the Fund. The Fund will accumulate money until it reaches a minimum of \$100,000 before any earnings will be spent from the Fund. The exception will be if the Fund accepts a gift that requires the expenditure of earnings for a specific program upon receipt. **PASSED 7-0**

EB19-079 – Board — The Executive Board moves to approve the resolution (attached) codifying the terms of agreement between the Kasparov Chess Foundation and US Chess for the annual All Girls National tournament. **PASSED 6-0** with Mike Hoffpauir absent and not voting.

EB19-080 – **Unruh** – I move to accept the 2019-2020 budget as presented. The budget must be presented to the delegates for approval. **PASSED 6-0** with Mike Hoffpauir absent and not voting.

EB19-081 – Board — The Executive Board recommends David Hater for a seat on the FIDE Ethics Commission and directs our President and FIDE Delegate to promote that candidacy. **PASSED 6-0** with Mike Hoffpauir absent and not voting.

EB19-082 – Board — The Executive Board moves to submit the following ADM: **PASSED 6-0** with Mike Hoffpauir absent and not voting.

To replace Article 4 Section 6 of the bylaws regarding the electronic voting process to read If US Chess implements an electronic voting system, voting members may request a paper ballot by writing to the US Chess office prior to May 1st for a regular election or the equivalent cutoff date for a special election.

Rationale: Current language references members who receive Chess Life by mail. However, paper ballots have not been bound into Chess Life for some time. Further, the current language seems to create a default of mailing paper ballots. If we have an electronic voting system the default ought to be to use the electronic voting system.

Allen Priest presented a Board motion by e-mail on June 13, 2019, to uphold the decision of the Ethics Committee in an appeal. Voting was completed on June 20.

EB19-083 – **Board** — The Executive Board moves to uphold the Ethics Committee's ruling in Kiewra vs. Koka that suspends the US Chess membership of Mr. Abhinav Koka (ID#: 16052137) for two years with the suspension beginning on 3/19/2019, the date the Ethics Committee submitted their ruling, and ending on 3/18/2021. **PASSED 7-0**

Mike Hoffpauir moved approval of Boyd Reed's suggestions to make two changes to the US Chess Invitational Requirements to clarify that a player who finishes clear first or in a first place tie in the US Senior Open qualifies for the US Senior Championship rather than the US Championship. The motion was made by e-mail on June 20, 2019. Voting was completed the same day. The first change was to change "US Championship" to "US Senior Championship". The second change was to clarify that if the first place player in the US Senior Open is already qualified to play in the US Senior Championship, the next highest finisher is not eligible to replace him or her. The same clarification applies to seeding from the US Open to the US Championship.

EB19-084 – **Hoffpauir** – I move that the following portions of the US Chess Invitational Requirements as regards the US Senior Open and US Senior Championship be approved by the Executive Board. **PASSED 7-0**

Issue #1: Original Language in Paragraph 2.1.1.5: "U.S. Senior Open Champion - For the U.S. Senior Open Champion to qualify for the U.S. Championship, they must satisfy the above residency requirements and earn clear first or a tie for first. In the case of a tie, the playoff results or the tournament tiebreaks will be used."

Proposed Solution #1: Change "U.S. Senior Open Champion - For the U.S. Senior Open Champion to qualify for the U.S. **Senior** Championship, they must satisfy the above residency requirements and earn clear first or a tie for first. In the case of a tie, the playoff results or the tournament tiebreaks will be used."

Issue #2: The current language does not provide guidance on how to handle instances where the winner and any cochampions of the US Sr Open are already qualified ... e.g. would the US Sr. Championship berth automatically pass to the next highest finishing player?

Solution #2: Boyd does not recommend the berth automatically flow down to the next player. To resolve the lack of clarification in the current draft rules, Boyd proposes the following additional (new) paragraph be inserted at the end of Paragraph 2.1.1: "2.1.1.7: For the U.S. Open and U.S. Senior Open, only players who finish clear first or tied for first are eligible for seeding into the U.S. Championship and U.S. Senior Championship, respectively."

Mike Nietman moved the acceptance of the minutes of the June 1, 2 Executive Board meeting by e-mail on July 26, 2019. The vote was completed on the next day.

EB19-085 – Nietman – I move to accept the minutes of our June 1-2, 2019 meeting that were previously distributed. **PASSED 6-0-1** with Mike Hoffpauir abstaining.

Carol Meyer moved the approval of a consulting agreement for the first phase of an IT Infrastructure Project on July 27, 2019. Voting was completed the next day.

EB19-086 – **Meyer** – I move to approve the Consulting Agreement with Skvare for Phase I of the US Chess IT Infrastructure project. **PASSED 7-0**

The EB held its last meetings with a closed session on 08/07/19 and an open session on 08/08/19 at the Rosen Centre Hotel in Orlando, FL Three motions were made in the closed session and votes were confirmed in the open session. All were concerned with overturning a TDCC appeal.

EB19-087 – Board — The Executive Board moves to overturn the TDCC decision in full in the matter of Tang vs. Voje. **PASSED 6-0-1** with Mike Hoffpauir abstaining as he was unavailable to hear the appeal.

EB19-088 – Board — The Executive Board moves to overturn the TDCC decision in full in the matter of Tang vs. Jackson Wahl. **PASSED 6-0-1** with Mike Hoffpauir abstaining as he was unavailable to hear the appeal.

EB19-089 – Board — The Executive Board moves to overturn the TDCC decision in full in the matter of Tang vs. Ned Wahl. **PASSED 6-0-1** with Mike Hoffpauir abstaining as he was unavailable to hear the appeal.

- 2. The Poster is Responsible. By accessing the Forums, you understand that all information, data, text, software, music, sound, photographs, graphics, video, messages, tags, or other materials (hereinafter "Content"), whether publicly posted or privately transmitted, are the sole responsibility of the person from whom such Content originated on these Forums. If you use (read or post on) these US Chess Forums you are indicating that you agree that US Chess is not responsible for the Content found here. Only the Executive Director, or the Executive Director's designees, including members of the Executive Board have the authority to post on these Forums on behalf of US Chess. Executive Board members and Delegates exclusively represent their own opinions and positions when posting on the Forums. Moderators may take actions on behalf of US Chess in conformance with this AUG, but they do not otherwise communicate on behalf of US Chess. To the extent that this AUG requires clarification, it will be construed by the Executive Director.
- 3. US Chess is NOT Liable for Content Posted on These Forums. The above, among other things, means that you, and not US Chess, are entirely responsible for all Content that you upload, post, email, link, transmit or otherwise make available via these Forums. US Chess does not control the Content posted on these Forums and, as such, does not guarantee the accuracy, integrity or quality of uploaded or posted Content. You understand that by using these Forums, you may be exposed to Content that is offensive, indecent or objectionable to your own personal beliefs. You may also be liable for any Content that you post that runs afoul of any law. - x. post repetitively;
- y. try to bypass the censors;
- z. spam, self promotion, and referral links are not allowed. Such links (including url shortener links such as bit.ly) may be automatically stripped;
- aa. upload, post, email, link, Private Message, transmit or otherwise make available any Content that calls the integrity of another person into question, states or suggests a person is a liar, or that contains deliberately insulting language, including but not limited to calling into question a person's loyalty, diligence appearance, intelligence, or sincerity.
- 5. The Moderation Queue; Suspension; Expulsion. US Chess' Executive Director and moderators have broad discretion to supervise the forums and Private Messages (PMs). If a member, or non- member in certain forums, violate this AUG, any two moderators may agree to place a poster in the "Queue" for up to 30 days. While in the Queue, a poster may continue to read and post in the forums; however, posts must be released by a moderator before they will be seen by other forum participants. Moderators may place a poster in the Queue twice within any twelve-month period year for up to 30 days on each occasion. If a third AUG violation warranting action in the moderators' view occurs within any twelve-month period, after placing the poster into the Queue for a third time, and then for every subsequent time thereafter, the moderators must immediately refer the poster to the Executive Director for possible additional action. Upon referral, the moderators may recommend any sanction available to the Executive. If the Executive Board needs additional facts, it will obtain them from the Executive Director, third parties, and/or the sanctioned member. The Executive Board will within sixty days of the appeal affirm the sanction, overturn the sanction, or modify the sanction. The member will be notified of the Board's decision by the Executive Director in writing.
- 7. US Chess May Delete Content. You acknowledge that US Chess may or may not pre-screen Content, but that US Chess and its moderators shall have the right (but not the obligation) in their sole discretion to pre-screen, refuse, delete, or move any Content that is available via the Forums. Without limiting the foregoing, US Chess and its moderators shall have the right to remove any Content (including off-topic posts) that violates this AUG or is otherwise objectionable at their sole discretion. You agree that you must evaluate, and bear all risks associated with, the use of any Content, including any reliance on the accuracy completeness, or usefulness of such Content. APPENDIX C - US Chess's Junior Tournament Player (JTP) Program

JTP Event Purpose

JTP events allow affiliates to run rated tournaments for groups of scholastic players where US Chess membership is not required.

JTP Event Structure

There are 3 types of JTP event participation levels:

- 1. Primary JTP events where each participant is 3rd grade or lower.
- 2. <u>K12 JTP events</u> An accredited school with a scholastic affiliate may run a K12 JTP event as long as each participant attends the school with the accreditation.
- 3. <u>Home School JTP Events</u> Home school students may participate in either the Primary JTP events or the K12 JTP events. To determine a home schooler's event participation level, consult the age-grade chart in 12.2.1 of the <u>Scholastic Regulations</u> (see below). The home school students in question must also meet the definition of a school in the scholastic regulations. Lastly, home school students forming a specific team must be from the same home school cooperative or individual group as per the scholastic regulations:
 - a. <u>SR13.2.1</u> A school is defined as an institution which is under one Head of School and serves one student body. A school may be located in one or more buildings, and on one or more campuses. A school must provide core curricular instruction as defined by state or local law or regulation. Schools with students on multiple campuses must seek prior approval from the US Chess Director of Events at least two weeks before the start date of the tournament to compete in a US Chess national scholastic event.
 - b. <u>SR13.2.1.1</u> A 'local public school' for a home schooled or virtual school student is defined as the public school the student would attend if attending public school. For example, the local public school for a 3rd grade home schooled or virtual school student is the local public elementary school whose geographic footprint, as defined by the applicable local department of education authorities, encompasses the student's home residence address.
 - c. <u>SR13.2.1.2</u> A 'public school district' is a grouping of public schools (most usually within a city or county, but may be a single school in a small city) recognized and designated as being a public school district by that state's department of education. A 'local public school' is not the entire district but is the area that a single public school covers.

Requirements

All participants must have a US Chess Member ID to participate. In order to generate the US Chess Member ID, you'll need to collect each participant's birthdate and mailing address information. For

some schools, this may require a parental consent form. Instructions on generating a US Chess Member ID for the participants who are not already US Chess members can be found in the **TD/Affiliate FAQ** support area. Whomever oversees rating the event will need to code the JTP event as a Primary JTP Event or K-12 In-School JTP Event. To change the Participant Coding, use the edit form in the TD/Affiliate Support Area. Note the K-12 JTP type will only be offered if the affiliate is a scholastic affiliate. Until the Participant Coding is changed to a JTP Event, any non-members will be flagged as errors.

JTP Restrictions

No adult players can participate in JTP events as formal participants or house players. This includes parents, coaches, and teachers. If a cross-section pairing is possible, ensure that the participants are both JTP eligible. If necessary, use the grade-age chart in 12.2.1 of the **Scholastic Regulations**.
