## From Open Session

Allen Priest presented the next motion.

**EB17-006** – **Priest** - Allen Priest moves that the Executive Board establishes a Clock Working Group. The purpose of the working group is to develop a list of clock features that are required and/or recommended by the US Chess Rules of Chess and any clock features required and/or recommended by the FIDE Laws of Chess that are not in conflict with the US Chess Rules of Chess. Also the group will produce a report as a service to our members and to people who are new to chess assessing haw various chess clocks meet those requirements. We expect that this list will be published on the US Chess website and made available at US Chess events.

This working group is not authorized to establish any list of "approved clocks", nor can it ask for any funding or fees from clock designers or manufacturers, nor can it officially authorize any manufacturer to list this list in advertising.

The working group is independent of clock designers and/or manufacturers, but may consult with them if the group deems necessary. Passed 6-0 with Randy Bauer absent and not voting

Priest announces the three chairs and members of the new Clock Working Group.

President Walters opened up the floor for questions and comments. Topics discussed were: Chess-athons; Life members and fundraising; promoting and fostering in women's and girls' chess; the Southwestern Tournament; movie Queen of Katwe; the direction of US Chess in the future; SuperNationals; World Championships; security at events; charter of the Development Committee; College scholarships; sponsorships; thanks to the Board and Jean Hoffman for their conservative approach to the budget; Ruth Haring and Gary Walters were recognized for the positive changes they made to US Chess; the importance of volunteers.

Mike Nietman introduced the next motion.

EB17-007 – Nietman - Mike Nietman moves to add Renate Otterbach to the Chess in Education Committee and Frank Niro to the Clubs Committee. Passed 6-0 with Randy Bauer absent and not voting

Gary Walters announced the November 2017 Executive Board Meeting will be held in New York along with the World Championship. Dates to be determined.
