Working Capital

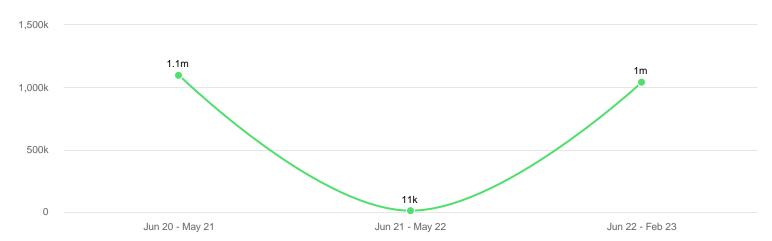

Change in Net Assets

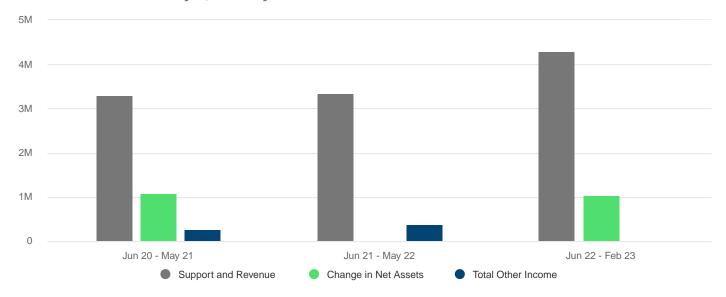


Change in Net Assets Quarterly

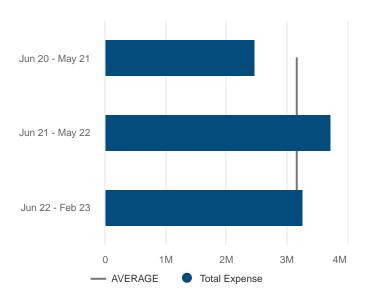




Profit & Loss Summary Quarterly
